1. To Field Office Manager: This is not a new case. This 3-page October 20, 2025 document is an update to the filing that was submitted in hardcopy form on October 14, 2025. To avoid redundant effort on anybody's part, please forward this to Area Director as part of the October 14, 2025 case. Thank you.

Background: The October 14, 2025 filing requested that Area Director initiate an investigation. That request supersedes the filing that was made on October 10, 2025. The October 10, 2025 filing requested that Area Director direct Mountain View, CA Office Manager Ying-Yu Hobbs to communicate. Subsequent to threats made by Ms. Hobbs on October 10, 2025, that is no longer requested.

- **2.** Note that this document and other documents moving forward will be posted on the following website: **yingyuhobbs.com** or **Ying Yu Hobbs dot com**
- **3.** I've received two notices from Social Security. That is the most recent snail-mail. The first, and significant, page of each notice is attached to this page. This page offers responses to each of the two Social Security notices.
- **4.** The Social Security notice that is attached as page 2 of this document is a response from Social Security to a Form 861 that I filed circa August 12, 2025. The August 12, 2025 Form 861 reported two [2] possible errors by Social Security related to overpayments to me:
- **4.1.** One overpayment, or set of overpayments, to me occurred in 2023. However, I've already partly repaid that overpayment, or set of overpayments, by virtue of the fact that I was entitled to receive a monthly payment in February 2025 for January 2025 and I did not receive it.

Ying-Yu Hobbs of SSA Mountain View has been well aware of this issue since the First Quarter of 2025. A senior Mountain View staff member was assigned to address the issue, but she exited due to illness. Ms. Hobbs' office remains directly involved due to the fact that a different staff member, who identified himself as "Joe", offered to address the error but indicated to me that **he would not do so unless I agreed to lie.** "Joe's" demand was illegal.

4.2. Another overpayment, or set of overpayments, to me was alleged to have occurred in 2024, but SSA agents have confirmed to me that the 2024 overpayment[s] never occurred in any way, shape, or form. The timing and nature of the 2024 allegation suggest that **it might be retaliation** by Ying-Yu Hobbs or "Joe" in Mountain View for my attempt to report the issue stated in part 4.1 above.

The Social Security notice attached as page 2 of this filing suggests that collection of the non-existent 2024 overpayment[s] has been suspended pending review. However, the notice doesn't seem to comment on modification of collection of the 2023 overpayment[s].

Social Security isn't necessarily required to modify collection of overpayments upon the filing of a Form 861. However, SSA agents tell me that this is usual policy. They agree with me that my Form 861 might not have been read closely by intake staff and that I should raise the issue.

I could file a second Form 861 that is solely about the 2023 overpayment[s]. However, SSA agents and I agree that this might lead to further confusion. A clarification will be appreciated. If no response is received, I assume that I should go ahead and file a second Form 861. However, it will be simpler if there is a response to this October 20, 2025 filing.

5. The Social Security notice attached as page 3 of this filing directs me to travel in person to Mountain View, CA to seek to speak with Ying-Yu Hobbs. Folks: I've initiated an Area Director complaint against Ms. Hobbs. She's threatened me with litigation and "law enforcement". **Does SSA truly wish to force Hobbs and me to meet in person** at this time? Additionally, I'm not located near Hobbs' office, **I'm physically disabled, and it's a burden to travel**. I want to go to more convenient offices.

At the very least, I'd like to be **formally released from any requirement** that I deal with the Mountain View office in the future. A review of misconduct in the current matter, **especially "Joe's" demand that I lie,** will be in the public interest regardless.
