You're SSA district managers in, IIRC, California. I do feel that you need to step into this matter and facilitate communication with the Area Director level. BTW Is that Nick Knox now? Understand that a matter that may include a prosecutable crime as one element has gone on for over 13 months now.

**Ms. Hobbs, Happy New Year.**

Failure to respond promptly to this letter, or a negative or threatening response, may necessitate physical delivery of related correspondence to the street address that was used previously. Proof of service, in this event, will be filed at the Area Director and/or Congressional Unit level.

*[ Editor's note: The preceding is a reference to the 4174 Beechwood Avenue, Fremont, CA address which appears on the October 09, 2025 proof of service that was filed with Social Security on October 10, 2025. The proof of service may be viewed on the yingyuhobbs dot com website. The take-away is that Ying-Yu Hobbs is aware of the allegations related to her and is not willing to address them. ]*

A threatening response from you such as the one that you offered me a few months ago will be treated as misconduct and potentially as a tort or a prosecutable crime.

This is especially true of statements to the effect that communication which you promised to engage in is "harassment" or inappropriate in any way, shape, or form. I \*will\* respond at all levels from SSA administrative up to Congressional Unit to such statements.

Additionally, be advised that, however things proceed, communication and/or steps in either direction will be documented for public and/or administrative review on yingyu hobbs dot com.

Moving on:

I'd thought that the SSA matter which I'd been attempting to raise at the Area Director level had been resolved. Not the part about the illegal threat that your staff member "Joe" made, but at least some of the technical issues. This was based on a print letter that SSA sent me in, IIRC, last October.

However, on Wednesday, January 07, 2026, an SSA agent in Antioch stated to me that, after 12 months of me trying simply to restart my SSA payments, and about 9 months of attempting to work through the matter with you personally as you had promised to speak with me, the matter continues to be unresolved.

I filed the appropriate form months ago. I was supposed to be granted a phone call as part of that process. No phone call was offered and my understanding now is that I'm still at square one. An adjustment to payments was made, but they skipped December and it's scheduled to revert in about one month regardless. It's the reversion that is of greatest concern.

You're involved based on your own verbal commitment to me and, more importantly, on the illegal threat that your staff member "Joe" made.

I've repeatedly offered sympathy related to the pressures that you and your staff have been under. None of it justifies how you've handled the current matter. You should be ashamed of your conduct.

I have a phone call from, I gather, a Tier 2 in Gilroy, CA scheduled for Monday morning. It isn't the call that I [was] supposed to get months ago. I request and expect that your office will agree to do what "Joe" told me months ago that he'd do if I agreed to lie as he demanded.

By the way, was that phone call recorded, have you listened to the recording, and will the recording, if it exists, reflect well on you?

I'd prefer to see confirmation of receipt of this letter prior to the scheduled Gilroy phone call. If that isn't possible, prompt confirmation and indication of intention to positively engage is requested.

Note again that, if there is no response to this letter, you may receive physical copies of this and/or related correspondence by direct delivery [as before] and/or electronic and/or physical copies by other channels.
